**VOLUNTARY RECALL of Camino Almonds Dark Chocolate Bar, 100 g
Lot Codes 22.06.12 and 23.08.12**

Dear client,

La Siembra Co-operative would like to inform you of our decision to voluntarily recall Camino Almonds Dark chocolate Bar, 100 g, Lot Code 22.06.12 and Lot Code 23.08.12, effective immediately.

Following consumer complaints made directly to the CFIA regarding extraneous matter found in this product, our manufacturer has determined that a single lot of almonds may have been contaminated by extraneous matter. This lot of almonds was used in the manufacture of lots 22.06.12 and 23.08.12 of our Almonds Dark Chocolate bar, distributed from February 17 to October 19, 2011.

Please note that no other Camino chocolate bars or other products are affected.

We believe that the CFIA will determine that this is a Class II recall: a situation in which the use of, or exposure to, a violative product may cause temporary adverse health consequences or where the probability of serious adverse health consequences is remote.

We ask that any distributors, stores or individuals who have inventory of either of these two lots of Camino Almonds dark chocolate bars stop selling them and destroy them immediately.
