**PART TWO | GUARANTOR INFORMATION****Guarantors (Minimum of Two)**

The guarantors, jointly and severally, accept financial responsibility for any and all outstanding debts incurred by the Buying Club named below until such time as replacement guarantors are accepted by the ONFC **OR** until a period of six months has passed from the receipt by the ONFC of the written resignation of the guarantor. During the six month period, the guarantor will continue full responsibility until either an acceptable replacement is provided to the ONFC or the expiration of the six month period from the date of receipt of the written resignation.

The phrase 'jointly and severally' means that each guarantor is technically and actually responsible for 100% of the outstanding debts rather than some share. In practice, the guarantors agree among themselves how the total of the debt will be shared.

When the departure of a guarantor leaves the Club with less than the minimum of two guarantors, the Club will be in default of its terms with the ONFC. The ONFC may, at its discretion, continue serving the Club with the remaining guarantor. The remaining guarantor will carry the burden of responsibility for the whole Club until the Club has two or more guarantors on record. It is the Clubs responsibility to notify ONFC of any changes within the guarantors.
